

Memorial Composite High School School Council Meeting Minutes March 14, 2022 Virtual Meeting

- 1. Call to Order
 - a. The meeting was called to order at 7:04 by Karissa Sparling.
- 2. Approval of Agenda
 - a. The agenda was approved by Arlene Fieldhouse.
- 3. Approval of Minutes
 - a. The Feb 28/22 minutes were approved by Karissa Sparling.
- 4. Correspondence
 - a. No information was provided.
- 5. Old Business
 - a. No information was provided.
- 6. New Business
 - a. ASCA Conference is April 22-24. MCHS will pay the fees to send several parent participants.
 - b. The ASCA Annual General Meeting was held. The Advocacy Resolutions Package 2022 was provided. Please refer to the ASCA for the full report. Three Proposed Advocacy Resolutions and one Administrative Resolution were submitted.
 - a. Diploma Exam Weighting Change The weight of diplomas was changed from 30% to 10% for the 2021-2022 school year due to COVID. The resolution is requesting that the diploma weight stay at 10%. Our parents concluded that they like the resolve but not as it is written. Our parents like the change but not just due to COVID.
 - b. Policy Review for Operations and Maintenance Funding There is a large amount of school maintenance work that is deferred because of lack of funds. PSD has ~\$55 million in deferred maintenance for the 24 sites. The resolution requests that the Minister of Education conduct a policy review, engage stakeholders, and work with municipal level government to ensure that the current and deferred maintenance of schools is dealt with to ensure access to safe and healthy schools. Our parents support this resolution.
 - c. Restoration of Funding for Alberta School Councils' Association ASCA has been defunded. The concern is that the parents' voice won't be heard. Our parents support this resolution.
 - d. Revise Advocacy Policy 12-2 High Risk Bus Stop Awareness and Signage The ASCA Board believes its advocacy efforts should be focused on the ministerial level, not the Alberta School Boards Association. Our parents support this resolution.
 - c. Future agenda items None were submitted at this time.

7. Reports

- a. Staff Mr. Stuckey
 - a. Matilda tickets are on sale for March 29 and 30 at Horizon Stage.
 - b. We have a Black Youth Club that just started up on Tuesdays at lunch. It's made and run by black students for black students - but everyone can take part in building a community of belonging through this club. They have a focus on building allies for the community, sharing knowledge and experiences, and empowering each other.
 - c. The MCHS Choir just filmed a WORLD PREMIERE choral piece, by award-winning Canadian composer, Marie-Claire Saindon. This collaboration between composer, poet Albertan Paul Grindlay, violinist Allyson Lyne, pianist Talesa Mandin, and our choral students will be premiered across the country on April 8.
 - d. Also, we are back to live choir concert performances! On April 14, at Horizon Stage, the choir will be presenting our first indoor public concert in three years!
 - e. On March 11, the Entrepreneurship class held a Dragon's Den-style event. Lindsay Kaminsky & Tasha Shepley from Beautifully Bazaar were the Dragons. Students were given the opportunity to wow the judges and could have their products displayed at Beautifully Bazaar.
 - f. The Business Competition Club participated in the SAIT Case Clash from March 4-11 for cash prizes of \$2600. The event was virtual. The presentations will be judged on YouTube between March 11-18 and winners will be announced in the first two weeks of April. On March 12, the students virtually participated in the first round of the MacEwan Business Challenge. Selected teams (announced on Wed. March 16) will move on to the final round of the in-person competition at MacEwan on Saturday, March 19. This year's team consists of Oliver Magnus, Gabriel Parent, Ryan Burton, Ryder Reaney, Benny Plante, Ryder Chambers, and Adrian Janzen.
